Surveyor's Narrative

The area graphically depicted and described hereon is the proposed Granite City Boundary. The proposed area is comprised of 18 separated Unincorporated Salt Lake County "tracts". These tracts of land are considered "islands" within the municipal boundaries of Sandy City, Utah. The purpose of this exhibit is to provide an accurate map along with a legal description of the depicted area to fulfill the requirements defined by Utah State Code under Title 10, Chapter 2a, Part 2, Section 202 Feasibility request – Requirements – Limitations. House Bill 330 removed the "contiguous area of a county" requirement of Title 10, Chapter 2a, Part 1, Section 202 Feasibility request – Requirements – Limitations and amended the code to be "an unincorporated area". This has allowed for the opportunity of a non-contiguous municipal boundary that is being depicted and described hereon. Furthermore, this map is not intended to serve as a Final Local Entity Plat and is subject to changes during the final annexation process.


