Subject: Benson Incorporation Feasibility Review

Introduction

By the January 17, 2024 request of the Utah Lieutenant Governor's Office, the Utah Population Committee reviewed the area of Benson in Cache County to determine whether it meets the population, population density, and contiguity requirements for incorporation as a town as defined in Utah Code 10-2a-201.5. We determined that Benson meets these requirements. This memo shares additional details of the review.

Results of Feasibility Criteria Review

Benson meets the population, population density, and contiguity requirements in Utah Code 10-2a-201.5. Table 1 summarizes the criteria and their applications to Benson.

Additional Information and Methodology

We calculated an approximation of Benson's 2020 Census population using block-level data. Using this value as a base, we then created a population estimate for July 1, 2023 using the housing unit method of population estimation – one of the most widely used methods for sub-national population estimates. This analysis uses a boundary shapefile based on Benson's certificate of petition created by the Utah Geospatial Resource Center (UGRC).

2020 Census Population

Benson's proposed boundary contains 38 blocks which are either fully or partially within the boundary. Using satellite imagery and parcel data, it was determined that two blocks contain some population within Benson's boundary and some population outside. The population of these blocks were

adjusted using the ratio of occupied housing units within the boundary compared to those outside the boundary (see Table 2). These adjustments resulted in an approximate 2020 Census population of 739.

Housing Unit Method

This method uses the approximate 2020 Census population as a base, then incorporates newly constructed housing units as a means of measuring population growth. Building permit data from Construction Monitor, a proprietary source of building permit data, are geocoded using a tool from UGRC. An assumed lag time of 6 months between permit approval and construction is used for single-family units. A total of four single-family units within Benson's boundaries were completed between April 1, 2020 and July 1, 2023. This household growth is multiplied by the average household size of 3.09 for Cache County¹, resulting in population growth for Benson of 12 people. This results in a July 1, 2023 estimated population of 751.

¹ Average household size is calculated by dividing the 2020 Census household population by occupied housing units.
